This Privacy Policy ("**Privacy Policy**") explains how Primus PVX LLC (now referred for convenience in this Privacy Policy as "Primus **PVX**", "**PVX**", "**we**" "**us**" or "**our**") uses personal information (individually and collectively, in whole and in part now referred to for convenience in this Privacy Policy as "**Personal Information**" or "**PI**"), including yours. ("Personal Information" is defined in **Section 1** below). This Privacy Policy is intended to comply with the California Consumer Privacy Act and the California Privacy Rights Act (the "**CCPA/CPRA**"), and applies to all individuals including but not limited to, those who reside in the State of California on or after the Effective Date above, who visit our website and/or app at [www.primuspvx.com](http://www.primuspvx.com) (individually and collectively now referred to for convenience in this Privacy Policy as the "**Site**"), subscribe to our services, send us emails, or purchase or access anything on or through the Site including but not limited to, the book "Valuing Fractional Interests in Real Estate 2.0" (all of the foregoing goods and services are now individually and collectively referred to for convenience in this Privacy Policy as "**Goods**," and those individuals, including you, who visit the Site are now sometimes individually and collectively referred to for convenience in this Privacy Policy as "**User(s)**", "**you**", or "**your**").

## 1. Categories and Specific Types of Personal Information

“**Personal Information**” is information we collect that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, to a particular User, household, or device. Please keep your PI accurate at all times.

### Categories of PI

A. Identifiers (e.g., your real name, aliases, postal address, company, unique personal identifiers, online identifiers, internet protocol (IP) addresses, email addresses, social Media addresses, account names, telephone numbers, social security number, drivers’ license and other government-issued identification numbers, passport number, and other similar identifiers).

B. Other information that identifies, relates to, describes, or is capable of being associated with you including but not limited to: your signature, physical characteristics or description, education, employment, employment history, onsite purchases, bank account numbers, credit card numbers, debit card numbers or any other financial information, medical information or health insurance information, areas of interest, areas of service, information collected from social media interactions, information about individuals who have referred Users to the Site or whom they have referred to the Site.

C. Characteristics of protected classifications under California or federal law (e.g., age (40 years or older), race, color, ancestry, national origin, citizenship, religion or creed, marital status, medical condition, physical or mental disability, sex, (including gender, gender identity, gender expression, pregnancy or childbirth and related medical conditions), sexual orientation, veteran or military status, genetic information (including but not limited to, familial genetic information).

D. Commercial information (e.g., records of personal property, products or services purchased, obtained, or considered, or other purchasing or consuming history or tendencies).

Names, email addresses, company names, mailing addresses, phone numbers.

above to create a profile about you reflecting your preferences, characteristics, psychological trends, predispositions, behavior, attitudes, intelligence, abilities, and aptitudes.

L. Other Information when you visit or leave the Site Cookies, as explained in our  
(e.g., our plugins, cookies or similar technology on the Cookie Policy (**Section 11**).  
sites or apps of others when you leave our Site. We usually receive the URL of both the site you came from and the one you go to next), your proxy server, operating system, web browser and add-ons, device identifier and features, ISP and/or your mobile carrier. If you use the Site from a mobile device, that device will likely send us data about your location based on your phone settings. In the unlikely event that we decide to use GPS or other location tools to identify your precise location, we'll ask you to Opt-In per **Section 6** of this Privacy Policy before we do.

Personal Information does not include:

- Publicly available information from government records;
- Deidentified or aggregated User information; or,
- Information excluded from CCPA/CPRA's scope including but not limited to: HIPAA, clinical trial data, and the Fair Credit Reporting Act.



## 2. How PVX Collects Personal Information

We collect PI when you visit the Site, contact us, purchase Goods on or through the Site, or otherwise interact with the Site. We may track the Goods you view or purchase, or other data. We use cookies and related technologies to collect information about the devices Users use to access and interact with the Site, and our business partners' sites including but not limited to, [www.primusivs.com](http://www.primusivs.com). You can read more about cookies and other technologies in Cookies and Related Technologies, **Section 11** below.

The social media platforms, or other methods of communication Users use to interact with PVX or the Site, may have their own specific privacy statements or policies that govern the use of Personal Information related to that platform or app. You should find and **CAREFULLY READ** those privacy statements and policies, as **OUR PRIVACY POLICY DOES NOT APPLY TO THOSE PLATFORMS OR APPS**.

We may receive additional Personal Information from third parties. We may use this Personal Information to enhance other information we have about Users to help us better understand them, and to otherwise enhance the Site, and/or the Goods.

## 3. How PVX Uses Personal Information

PVX uses Personal Information for the following reasons:

- Auditing related to a current interaction with you;
- Responding to User questions and inquiries;
- Detecting security incidents, protecting against malicious, deceptive, fraudulent, or illegal activity, and prosecuting those responsible for that activity;
- Debugging to identify and repair errors that impair existing intended functionality;
- Short-term, transient use, provided the PI is not disclosed to a third party;
- Performing services on behalf of a business or service provider with whom we have a relationship including but not limited to, maintaining or servicing accounts, providing customer service, processing or fulfilling orders and transactions, verifying your information, and processing payments;
- Undertaking internal research for technological development and demonstration; and,
- Undertaking activities to verify or maintain the quality or safety of a service or device that is owned, manufactured, manufactured for, or controlled by us, and to improve, upgrade, or enhance the service or device that is owned, manufactured, manufactured for, or controlled by us.

(All of the above bullet points in this **Section 3** are each an example of a “business purpose,” which is defined in **Section 4** below).

- Operating and improving the Site;
- Facilitating and processing orders for Goods including but not limited to, their purchase and shipping;
- Tracking Users purchasing and/or use habits of Goods, and performing other analytics;
- Managing and developing our business and operations;
- Communicating and providing additional information that may be of interest to Users about PVX and our merchants and business partners, such as newsletters, special offers, curated content, and announcements, but only that in which a User has elected to participate;
- Sending Users reminders, technical notices, updates, security alerts and support, administrative messages, service bulletins and marketing information;
- Sending Users other information we believe may be pertinent to their use of the Site, via email messages, text messages, apps, phone calls, and other methods of communication;
- Adding to our contact database; and,



- Managing our everyday business needs, such as Site administration, forum management, fulfillment, analytics, enforcement of our corporate reporting obligations, our Terms of Use, or to comply with the law.

#### 4. With Whom PVX Shares Your Personal Information

We routinely share Personal Information with:

- Service providers we use to help deliver our Goods to you, such as payment service providers, and delivery companies;
- Affiliated companies (such as our subsidiaries and other companies owned and/or controlled by or affiliated with PVX); and,
- Other service providers we use to help us run our business, such as sites through which one can subscribe to our Goods, website hosts, and those third parties set out in **Section 3** above.

We may disclose, subject to your Opt-Out and Opt-In Rights discussed in **Section 6** below, your PI to a service provider or processor solely for a business purpose. A “**business purpose**” is defined as the use of PI for our or a service provider’s (“**SP**”) operational purposes, or other notified purposes, provided that the use of PI is reasonably necessary and proportionate to achieve the operational purpose for which the PI was collected or processed, or for another operational purpose that is compatible with the context in which the PI was collected. When we disclose PI for a business purpose, we, as the “controller,” enter into a contract with that processor that describes the purpose and requires the recipient to both keep that PI confidential, and not use it for any purpose except performing the contract. (The CCPA/CPRA prohibits service providers who receive the PI we hold from redisclosing it, unless you have received explicit notice and an opportunity to Opt-Out of further disclosure).

#### 5. Disclosure of Personal Information to Third Parties

In the preceding twelve (12) months, we have not disclosed PI to a third party.

#### 6. No sale of Personal Information

We do not and will not sell your PI.

#### 7. When, Why, and To Whom PVX Discloses Personal Information

We will not disclose your Personal Information to third parties except to:

- Affiliated companies (such as our subsidiaries and other companies owned and/or controlled by or affiliated with PVX) who may only use the Personal Information for the purposes described in **Section 3** above;
- Third party merchants, but only to the extent a User has participated in an activity sponsored or offered through PVX on behalf of that merchant. We may also provide merchants with Personal Information to combat fraud and as part of legal proceedings affecting PVX and that merchant;
- PVX business partners as part of an offer or other activity that is provided by or in conjunction with PVX and/or its business partners, and in which a User has elected to participate. For example, if a User is referred to PVX from a business partner’s website or through an invitation facilitated by or in conjunction with a PVX business partner, we may provide that business partner certain PI to validate the referral, and to support the terms of the relationship between us and that business partner. This in turn may allow that business partner to contact you directly and/or to advertise to you;
- Effect or evaluate a merger, acquisition, or otherwise to support the sale or transfer of some or all of our business assets;



- To enforce our rights or protect our property;
- To protect the rights, property, or safety of others, investigate fraud, respond to a government request; or, as needed to support auditing, compliance, and corporate governance functions; and,
- To defend ourselves in litigation or a regulatory action and when required or advised to do so by law or our legal counsel in their representation of us. This includes but is not limited to, in response to a subpoena or similar legal proceedings, including to law enforcement agencies, regulators, and courts in the United States and other countries.

We encourage our third-party merchants and business partners to adopt and post their own privacy policies, since they are **NOT** covered or governed by ours. So, **THE USE OF YOUR PERSONAL INFORMATION BY THIRD PARTIES YOU CAN ACCESS THROUGH THE SITE, OR WHO PROVIDE GOODS OR INFORMATION ON OR THROUGH THE SITE, IS GOVERNED BY THEIR PRIVACY POLICIES, AND IS NOT SUBJECT TO OURS.**

You will be notified by email and we will post a prominent notice on the Site of any changes in ownership or uses of your Personal Information, as well as of any new or different choices you may have regarding your Personal Information.

We may also disclose information about Users that is not personally identifiable. For example, we may provide our merchants, business partners, or other third parties with reports that contain aggregated and statistical data about our Users.

## 8. Your Rights and Choices, Including Opt-in and Opt-Out Rights

The CCPA/CPRA provides California residents with specific rights regarding their Personal Information. This section describes your CCPA/CPRA rights and explains how to exercise those rights.

**8.1 Accessing, Correcting and Deleting Personal Information.** We think that you benefit from a more personalized experience when we know more about you and the kinds of Goods you like. However, you can limit the information you provide to PVX and you can limit the communications that PVX sends to you.

It is important that you keep your Personal Information current and accurate at all times by: logging into your account through our Site and selecting "[My Account](#)"; sending us an email at [support@primuspvx.com](mailto:support@primuspvx.com) and including "Privacy" in the subject line, or by postal mail, phone, or fax at the address at the end of the next sentence. If you want to close your account, need help with accessing, updating and deleting your personal information, or have other questions or requests, please contact our customer service department at [support@primuspvx.com](mailto:support@primuspvx.com) or by postal mail, phone or fax at:

You can manage your email preferences by contacting support at [admin@primuspvx.com](mailto:admin@primuspvx.com). You can also manage your subscriptions by following subscription management instructions contained in some of the messages that we send you. You can update your subscription preferences whenever you want. Please note that even if you unsubscribe from promotional email messages, we may still need to contact you with important transactional information related to your account, subscription and/or purchases. For example, even if you have unsubscribed from our promotional email messages, we will still send you confirmations when you purchase Goods from us.

You may manage how your browser handles cookies and related technologies by referring to **Section 11** below.



While we're ready to assist you in managing your Personal Information or closing your account, we can't always delete records of past interactions and transactions. For example, we're required to retain records relating to previous purchases on the Sites for financial reporting and compliance reasons.

We will retain your information for as long as you have an account with us, to provide you Goods and other goods and services, to maintain a record of your transactions for financial reporting purposes and otherwise as we feel is necessary to comply with our legal obligations, resolve disputes and enforce our agreements.

**8.2** You have the right to request that we disclose to you information about our use and collection of your PI (a "**Right to Know**") over the past twelve (12) months. Once we receive and have verified the request, we will disclose this information to you within 45 days.

**8.3** You have the right to request that we permanently delete, deidentify, or anonymously aggregate with the PI of others, all or parts of your PI (a "**Right to Delete**"). However, we can deny a Right to Delete request when the PI is needed to:

- Complete the transaction for which we collected the PI;
- Fulfill the terms of a written warranty or product recall conducted under applicable law;
- Provide goods or services you previously requested;
- Otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, or prosecute those responsible for that activity;
- Debug and repair errors that impair Site functionality;
- Exercise a legal right, such as free speech rights;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest;
- Enable internal uses reasonably aligned with your expectations based on your relationship with us;
- Comply with a legal obligation; or,
- Otherwise use your PI internally in a lawful manner that is compatible with the context in which you provided the PI.

We will inform the requester that we received the request within ten (10) days of our receipt, and how we will process the request. If we deny all or part of a Right to Delete request, we will respond to the requester the reasons for any denials not prohibited by law.

We will maintain a record of all requests, and how they were responded to, for at least twenty-four (24) months. Please note that only two requests are allowed in any twelve (12) month period. However, the categories of sources and purposes need not be specified for each category of PI identified.

#### Identifying and Verifying the Requester

To identify and verify the requester, we associate the information provided in the verifiable request to any of your PI previously collected by us. "**Verify**" means determination by us that the requester making a Right to Know request, Right to Delete request, Right to Opt-Out request, or Right to Opt-In request, is about your PI, is you, or someone properly authorized by you, or is your parent or legal guardian if you are under 13 years of age.

We verify requests associating the information provided to us in the request to any of your PI we previously collected. We can't require that you notarize a request, but we can ask for the request to be a signed declaration under penalty of perjury, request the requester to identify goods or services you recently purchased, or the dollar amounts of those recent purchases.



### How to Make Requests

Only you, or someone legally authorized to act on your behalf, may make a verifiable request related to your PI. The request must provide sufficient information that allows us to properly understand, evaluate, and respond to it, as well as reasonably verify you are the person about whom we collected PI or an authorized representative of that person. Your request should at a minimum include the following:

- Your account number, the approximate date you opened your account, and your password for the Site;
- When you last purchased something on the Site, and the dollar amount of that purchase;
- The type of request you are making; and,
- The specific PI to which your request pertains.

You may also make a verifiable request on behalf of your minor child, although the Site is not intended for use by anyone under the age of 18 years of age.

You can also designate an **authorized agent** to make a request for you. To designate an authorized agent, you must provide your:

- account number, date approximate you opened your account, and your password for the Site.
- a copy of your email or other correspondence to your agent, verifying you want that person to act as your agent in this regard, from the email address of yours which you have on file with us, with the agent's contact information in it, so we can verify your request.

Requests to us can be made by either:

- Calling us at +1 (800) 290-2644;
- Emailing us at [support@Primuspvx.com](mailto:support@Primuspvx.com) and placing "PI Request" in the subject line; or
- Visiting our Site page to make a request, at [www.primuspvx.com/contact-us](http://www.primuspvx.com/contact-us).

If new PI of yours is obtained by us so we can verify the request, we will only use it for that verification and then delete it, unless the requester consents otherwise.

We cannot respond to your request or provide you with PI if we cannot verify your identity or authority to make the request, and confirm that the PI relates to you, within forty-five (45) days of our receipt of your request.

### Request Response Timing and Format

We endeavor to respond to verifiable requests (e.g., to disclose, delete, effectuate Opt-In or Opt-out) within 45 days of our receipt of it. If we require more time, which can be up to an additional 45 days, we will within the initial 45 days inform the requester of the reason for and length of the extension period in writing.

If you have an account with us, we will deliver our written response to that account. If you do not have an account with us, we will deliver our written response by postal mail or electronically, at your option.

Any disclosures we provide are required to cover only the twelve (12) month period preceding our receipt of the verifiable request, but we will make a reasonable effort to comply with a request beyond that date, if it is possible. The response we provide will also explain the reasons we cannot comply with a request, if applicable.





For all requests, we will select a format to provide your PI that is readily useable and should allow you to transmit the information from one entity to another entity without hindrance including but not limited to, an email that can be forwarded.

#### Other Request Matters

We do not charge a fee to process or respond to a verifiable request unless it is excessive, repetitive, or manifestly unfounded. If we determine that the request warrants a fee, we will tell the requester why we made that decision and provide the requester with a cost estimate before completing the request.

Please note that we do not change our practices in response to a “Do Not Track” signal in the HTTP header from a browser or mobile application, however, most browsers allow you to control cookies, including whether or not to accept them and how to remove them. You may set most browsers to notify you if you receive a cookie, or you may choose to block cookies with your browser.

You can also manage the sharing of certain of your Personal Information with us when you connect with us through a social media platform or app, such as through Instagram, Twitter, Facebook, or LinkedIn. Please refer to the privacy policies and settings of the social media platform or app to determine how you may adjust our permissions and manage the interactivity between PVX and that social media account.

If you wish to Opt-Out of receiving offers directly from PVX’s merchants or business partners, you can follow the Opt-Out instructions in the emails that they send you.

**8.4.** We do not knowingly acquire the PI of Users we actually know are under 18 years of age.

**8.5.** We do not sell your Personal Information.

### **9. Non-Discrimination**

We will not discriminate against you for exercising any of your CCPA/CPRA rights. Unless permitted by the CCPA/CPRA, we will not:

- Deny you Goods;
- Charge you different prices or rates for Goods, including through granting discounts or other benefits, or imposing penalties;
- Provide you a different level or quality of Goods or other services; or,
- Suggest that you may receive a different price or rate for Goods, or a different level or quality of Goods or other services.

### **10. CCPA/CPRA Compliance Training**

We will inform our employees and any others responsible for handling User inquiries about our privacy practices and our compliance with the CCPA/CPRA, of all requirements set out in the CCPA/CPRA, how to effectuate those requirements, and how to direct Users to exercise their rights under the CCPA/CPRA.

### **11. Cookies and Related Technologies**

When Users use the Site, we collect certain information by automated or electronic means, using technologies such as cookies, pixel tags, clear gifs (also known as web beacons and web bugs), browser analysis tools, and web server logs. A “**clear gif**” is a nearly invisible, pixel-size graphic image on an app, website page, app or website-based document, or email. It helps us do things like view the URL of the page in which the clear gif appears, and the time our Site and the email in question is viewed. In emails, clear gifs help us confirm the receipt of and respond



to our emails including but not limited to, those that Users forward to friends and family, as well as to help us deliver a more personalized online experience.

As a User uses the Site, their browser and other devices, like certain types of phones and tablets, communicate with servers operated by us, our business partners and service providers, to coordinate and record the interactivity and fill their requests for Goods and information.

The information from cookies and related technology is stored in web server logs and also in web cookies kept on the computers or other devices from which Users access the Site. This information is then transmitted back to the Site by these devices. These servers are operated, and the cookies managed, by us, our business partners, or our service providers.

For example, when a User visits the Site, PVX and/or our service providers may place cookies on that computer or device. Cookies allow us to recognize the User when they return and to track and target your interests in order to provide a customized experience. They also help us to detect certain kinds of fraud.

A "**cookie**" is a small amount of information that a web server sends to your browser. It stores information about your account, your preferences, and your use of the Site. Some cookies contain serial numbers that allow us to connect your Site activity with other information we store about you or as related to your interactions with the Site.

Some cookies are temporary, whereas others may be configured to last longer. "**Session**" cookies are temporary cookies used for various reasons including but not limited to, managing page views. Browsers usually erase session cookies once the browser is exited. "**Persistent**" cookies are more permanent cookies that are stored on the computers or other devices people use even beyond when they exit their browser. We use persistent cookies for a number of purposes. These include but aren't limited to, retrieving certain information a User has previously provided (like their password, if they asked to be remembered), and storing that User's preferences, such as the types of Goods in which they've told us they're interested.

"**Pixel tags**" are tiny graphic images placed on website pages or in our emails that allow us to determine whether a User has performed certain specific actions. When that User accesses these pages or opens our email messages, the pixel tags generate a notice of that action to us and/or our service providers. These tools allow us to measure response to our communications and improve our web pages and promotions.

We collect many different types of information from the devices a User uses to access the Site, using these cookies and other technologies. Some examples of this information are the User's operating system type, browser type, domain and other system settings, the language the User's system uses, and the country and time zone of that device. Browsers routinely send these types of information to web servers. Our server logs also record the Internet Protocol ("**IP**") addresses of the devices a User uses to interact with the Site. An "**IP address**" is a unique identifier that devices use to identify and communicate with each other online. We may also collect information about the website or app a User was visiting before they came to the Site, and the app or website they visit after they leave the Site, if this information is supplied to us by the User's browser.

In many cases, the information we collect using cookies and other technologies is used in non-identifiable ways, without any reference to Personal Information. For example, we use information we collect about Users to optimize the Site and understand its traffic and usage patterns. Another example is we associate the information we collect using cookies and related technologies with Personal Information. In that case, this Privacy Policy governs how we use that information.
